

A Gymboree party is for children turning 1,2,3,4 and 5 years. The party lasts for 2 hours (with an option to extend it by 30 minutes). It is for a maximum of 20 children. You may arrive 30 minutes before the party starts to set up and must have left 15 minutes after the end of the party time. (For any time after that there will be a CHF 50 charge). You and your guests have access to the whole play area downstairs and the party snack room upstairs (not the small classroom upstairs). You will be bringing your own food and drinks for the children and adults, as well as plates, cups etc and any decorations you need. Please note that food and drinks are not allowed on the play floor. The children must have their snack and cake upstairs (not in the little kitchen area downstairs).

Coronavirus: You must keep a list of contact details for all participants for 14 days and be able to send it to the cantonal doctor's service, on request, in order to be able to trace potentially infected people if a positive case is detected.
